ABOUT THE MANUFACTURER

PRODUCT DESCRIPTION

Geberit FlowFit system pipe PB is a single-layer plastic pipe made of polybutene, used as part of the Geberit FlowFit supply system for building services installations. The declaration covers Geberit FlowFit system pipes PB without insulation, supplied in coils in protective pipe in different nominal diameters and lengths. For potable-water applications, the pipes are supplied in grey. The pipes can be uniquely identified and traced via the printed production date. The EN/ISO standard, manufacturer, operating temperatures, pipe diameter and wall thickness are also indicated.

Geberit FlowFit system pipe PB consists of polybutene (PB). The pipe is characterised by high stability, chemical resistance, and corrosion resistance. Geberit FlowFit system pipes PB are available in diameters 14/16/20/25 mm. Temperature resistance is continuous for drinking water: 0–70 °C and for heating: up to 80 °C, at a maximum pressure of 10 bar. Short-term loads up to 95 °C for drinking water and 100 °C for heating are possible for a maximum of 100 hours over 50 years. With proper use, a service life of 50 years can be assumed, based on EN 806-2.

Geberit FlowFit system pipes PB are intended for use in residential, commercial, industrial, and public buildings. Typical applications include potable-water installations, compressed-air distribution, and vacuum systems. The technical specifications refer to EN ISO 21003-2 and EN 806-2 (potable water). In addition, country-specific test standards apply, including national and international sanitary and installation regulations, to demonstrate conformity and performance.

To optimally coordinate the functional areas, fittings, valves and fastening material are offered. For planning, the Geberit ProPlanner is available, which allows country-specific regulatory requirements to be considered during planning. For processing the FlowFit supply system, tools for pipe preparation (cutting, deburring, pressing) are offered. The tools are matched to the system and contribute to the overall functionality and reliability of the installation.

A Geberit FlowFit system pipe PB with an outer diameter of 20 mm, a length of 50 m, and article number 619.241.00.1 is used as the reference product. The environmental impacts declared in this EPD are based on this reference product and are representative for all product variants within the defined scope. This EPD applies a reference product-based grouping approach. The products included differ primarily in geometric parameters such as diameter and length, which result in different masses and material distributions per functional unit. All products included fulfil the same function and are manufactured using the same materials, production technology, and manufacturing site. The declared environmental impacts are therefore considered representative for all Geberit FlowFit system pipes PB within the scope of this declaration. The product description is consistent with the underlying LCA project report.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impact taken into consideration for the product stage covers the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. The energy used by machines and handling of waste formed in the production processes at the manufacturing facilities are also included in this stage. Furthermore, the study takes into consideration the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilised in the factory.

The Geberit system pipe PB is made of polybutene (PB). Further information on supply chain sustainability and material procurement can be found in the Geberit Annual Report.

Transport from suppliers to Geberit is modelled based on material-specific transport distances. The individual transport distances of each supplier are

averaged according to the corresponding purchased amounts. All A2 transports are carried out by lorry. Transport by rail, sea freight or air is not taken into consideration due to lack of relevance.

Pipe extrusion takes place at the production site in Givisiez, Switzerland. The Geberit plant is certified according to ISO 9001, ISO 14001 and ISO 45001. The current Group ISO certificate can be downloaded from <https://www.geberit.com>.

Material- and production-related losses are included. Manufacturing waste from the pipe extrusion process is collected and recycled externally. Manufacturing waste is transported to the closest waste disposal facilities by lorry, estimated to be 50 km away. The sources of electricity consumed in the Givisiez plant for the manufacturing process are modelled as 100 % renewable.

The production and provision of packaging material are modelled in A3. The finished product is packaged with cardboard and plastic foil. Other packaging materials fall under the cut-off rules.

The use of green energy in manufacturing is demonstrated through contractual instruments (GOs, RECs, etc.), and its use is ensured throughout the validity period of this EPD.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts resulting from final product delivery to construction site (A4) cover direct fuel exhaust emissions and environmental impacts of fuel production, as well as related infrastructure emissions.

Transport from Geberit to customers within Europe is carried out by logistics partners via the modern, efficient Logistics Centre in Pfullendorf, Germany, which is certified according to ISO 9001, ISO 14001 and ISO 45001. Distribution to countries outside Europe is not taken into consideration due to lack of relevance.

The following information has been taken into consideration:

- Most transport within Europe is carried out by lorry, so intercontinental transport by sea and air is not taken into consideration.
- Most of the vehicles in use are > 32 t, Euro 6 class (> 85 %).
- The average transport distance in Europe from the production site to the Logistics Centre and to the customer is approximately 600 km.
- Capacity utilisation factor according to c-PCR

Further information on logistics can be found in the Geberit Annual Report. In A5, installation loss according to c-PCR was modelled and assumed to be recycled. Installation is carried out by a professional plumber. Detailed installation information is available. The preparation for waste treatment of packaging materials is included in A5. Plastic and cardboard are assumed to be partly incinerated, recycled and landfilled, according to Eurostat.

PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase. Air, soil, and water impact during the use phase has not been studied.

The product does not consume any electricity in use. Periodic maintenance is not necessary. Under conditions normally encountered in water supply pipes and fittings in buildings, Geberit FlowFit system pipes PB have a service life of at least 50 years (in accordance with EN 806-2).

PRODUCT END-OF-LIFE (C1-C4, D)

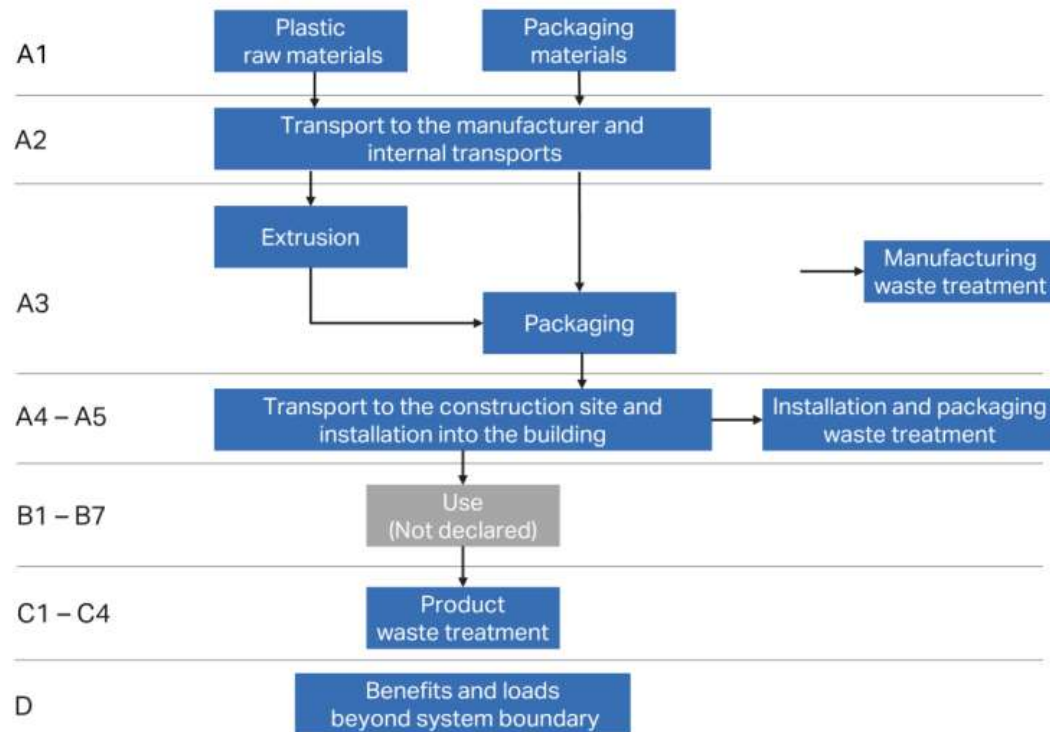
As the consumption of energy and natural resources for disassembling the product at its end-of-life is negligible, the impact of demolition is assumed to be zero (C1). The product reaches its end-of-life when the building is demolished or the bathroom renovated. The place of end-of-life is assumed to be identical to the place of installation (Europe).

It is assumed that all waste is collected and professionally separated after demolition at the construction site. The end-of-life product is transported by lorry to the closest waste disposal facilities, with an assumed transport distance according to the applicable c-PCR (C2).

The type of waste treatment is determined based on the material class. Furthermore, the properties of waste from sanitary systems and the respective current waste treatment technologies have been taken into consideration. Plastics are disposed of in a municipal waste incineration plant. Although the plastic components of the product are very well suited for recycling due to their material properties, they are conservatively modelled with thermal energy recovery (C3). The product is not biodegradable.

In Module D, benefits and loads beyond the system boundary are considered for material recycling and energy recovery at the end-of-life of the product (Modules C1–C4) and of packaging waste generated in Module A5. Energy recovery from incineration is modelled as part of the applied waste treatment background datasets. The recovered electricity and heat are assumed to substitute average European electricity (medium voltage) and European district or industrial heat production other than natural gas.

LIFE CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes that are stated as mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes for which data is available are included in the calculation. There is no neglected unit process with more than 1 % of total mass or energy flows. The module-specific total neglected input and output flows also do not exceed 5 % of energy use or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterisation factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are made as per the reference standards and the applied PCR. In this study, allocations have been made in the following ways:

A4: Transport distance represents a conservative average. The transport distance for distribution was calculated as a sales-volume based weighted average according to the percentage ratios for each destination point.

C2: Transport distance to waste handling facility is modelled according to cPCR.

C3, C4, D: The recycled end-of-life materials are assumed to serve as secondary raw materials in manufacturing, while the incinerated materials partly displace electricity and heat production.

This EPD applies a grouping type “Multiple products”, as several highly similar articles are included. The applied grouping method is a reference product-based functional grouping. A Geberit FlowFit system pipe PB (art. no. 619.241.00.1) with an outer diameter of 20 mm and a length of 50 m is defined as the reference product.

The reference product represents all FlowFit system pipes PB with:

- the same technical function (distribution of potable water in building installations),
- identical material composition based on polybutene (PB),
- identical manufacturing process and a single manufacturing site.

Product variants within the group differ only in geometric parameters such as diameter, coil length (e.g. 25 m or 50 m), and packaging configuration. These variations result in minor differences in mass and material distribution per declared unit.

The average product group is technically characterised by a single-layer polybutene pipe with high chemical and corrosion resistance; environmental impacts are primarily driven by product mass per declared unit, while technical and functional properties remain identical across the product range.

A calculation was performed for minimum and maximum product variants. The resulting GWP-fossil values for A1–A3 show a variation below 1 % compared to the reference product. This minimal variation is caused by small differences in the proportion of pipe material and protective pipe and minor differences in packaging depending on diameter and coil length. The variation in GWP-fossil is determined based on differences in product mass and material composition between the minimum and maximum configurations and the reference product. Due to the very low variation, the declared results are considered representative for the entire product group.

Due to the applied grouping and averaging approach, this EPD is valid only for Geberit FlowFit system pipes PB within the defined product group and configuration boundaries and shall not be used for products made of different materials, production technologies, or manufacturing sites not included in this declaration. The declared results are valid for products manufactured at the declared production site in Europe and are not representative for products manufactured outside this geographical scope or under different energy supply and production conditions.

To calculate results for the reference product per meter or per item, the following scaling applies:

Article GWP-fossil per m = GWP-fossil/kg * specific weight per m

Article GWP-fossil per item = GWP-fossil/kg * specific weight per item

The specific weight per m or item can be found in technical datasheets available in local online product catalogues. To calculate results for other product variants in m or per item, scaling can be performed similarly.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator for EPD Hub V3 and EPD Process Certification v3.2.3. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1/3.11 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1/3.11 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'. EN 806-2 was used as an additional reference for the reference service life. Eurostat statistics have been applied to some waste treatment scenarios.

ENVIRONMENTAL IMPACT DATA

The estimated impact results are only relative statements which do not indicate the end points of the impact categories, exceeding threshold values, safety margins or risks.
